## **Document Return Checklist**

Please make sure you upload files for ALL the below documents before completing your online enrolment application to ensure the timely processing of your child/ren's enrolment.

4	For <u>non-Australian</u> citizens & Temp visa holders – copy of student and parents passport, visa and travel documents	
5	Medical/healthcare or emergency action plans – ASCIA Plan	
6	Evidence of any disability or support needs – learning and support plans/NDIS	
7	Family law or relevant court orders
